## LIABILITY RELEASE AND INDEMNITY AGREEMENT

In consideration of being able to participate in the regatta mentioned above at Rehoboth Bay Sailing Association on September 20, 2025, I \_\_\_\_\_\_\_\_, for myself, my children, heirs, personal representatives, and/or assigns, and for all my guests participating in such activities with me, hereby agree to the following:

 Knowledge of Sailing, Regattas and Water Activities: I represent and warrant that I am fully familiar with sailing, racing, regattas and understand how to sail, am experienced in sailing and know how to handle, race and sail a sailboat.
Safety: I represent and warrant that I and everyone on the boat with me will at all times wear a U.S Coast Guard approved personal flotation device (life jacket), will stay inside the boat at all times, and will call for help if needed. I recognize that I must stay within view of RBSA on Rehoboth Bay at all times. I further represent and warrant that I am aware of the weather and believe it is appropriate for sailing, and will head back to RBSA if at any time, the weather changes and/or I feel unsafe.

Acknowledgement of Risks: I acknowledge there are many risks present in 3. sailing and/or racing a boat, participating in sailing, participating in water sports activities including but not limited to: (i) changing water flows, tides, currents, wave action and ship wakes; (ii) other boats on the water including but not limited to motor boats, sailing boats, fishing boats and lines, commercial boats, and manmade and natural hazards and objects; (iii) wind shear, inclement weather, lightning variances, low tides, sand bars, obstructions in the bay, and extremes of wind, weather and temperature; (iv) my own and my passengers sense of balance, physical coordination, ability to operate equipment, hypothermia, and/or drowning; (v) collision, capsizing, sinking and/or other hazard which may result in wetness, physical injury, exposure to the elements, hypothermia, drowning, and/or death; (iv) the presence of insects and marine life forms; (vii) equipment failure and/or operator error; (viii) heat or sun related exposures resulting in exposure and/or injuries including but not limited to sunburn, sunstroke, and/or dehydration; (ix) fatigue, chill and/or dizziness, which may diminish my and our reaction time and increase the risk of accident, physical injury, and/or death.

4. **Express Assumption of the Risk**. I agree to assume responsibility for all risks in any way associated with sailing, racing and/or this regatta activity for myself and the passengers on the boat with me, whether identified above or not. My/our participation in this sailing and racing water sport activity is purely voluntary. I assume full responsibility for myself and any passengers on the boat for which I am responsible, for any bodily injury, accident, illness, paralysis, death, and/or loss of personal property, as well as any expenses for damage to the sailboat, to any other boat, or to RBSA as a result of any occurrence, accident, or happening that occurs while I am renting the sailboat and engaging in the water activities.

5. **Release**. I hereby forever fully and completely release and discharge Rehoboth Bay Sailing Association, its principals, directors, trustees, officers, employees, agents, members, and volunteers FROM AND AGAINST ANY AND ALL LIABILITY OF ANY NATURE FOR ANY AND ALL PERSONAL INJURY (INCLUDING DEATH) OR DAMAGE TO ME AND ANY PASSENGERS ON THE SAILBOAT I AM RENTING REGARDLESS OF NEGLIGENCE OR FAULT. (Delete the "TO")

6. **Indemnity**. I hereby indemnify and hold harmless Rehoboth Bay Sailing Association, its principals, directors, trustees, officers, employees, agents, members, and volunteers from and against any and all personal injury and/or

damage caused in any way by me during my participation in the regatta referenced above.

7. **Governing Law and Jurisdiction**. This Agreement is governed and to be interpreted under Delaware law. The parties acknowledge and agree that jurisdiction of any claims related in whole or in part to anything under this Agreement shall be in courts located in the State of Delaware.
